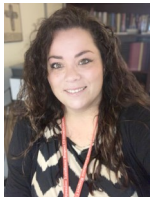
Samantha Satchell-Smith - Volunteer Commissioned Minister

Dave is the Vice President of Advancement for VOANR. He believes that we are all called to love those in need, that's why he works for VOANR and what he seeks to do each day.

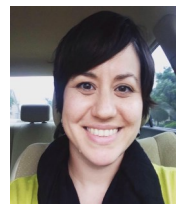
